## PROSPECTUS

### INTRODUCTION:

Entry forms (click here) are available on the PFSA website and should reach the Organising Committee by **01 July 2025** (see clause 3).

Exhibits should be delivered to the Organising Committee by **2 September 2025** at 10:00.

### 1. STATUS OF EXHIBITION

1.1 The Exhibition will be both competitive and non-competitive and open to all members of Societies affiliated to *The Philatelic Federation of South Africa (PFSA)* and all members of Federations affiliated to the *Federation Internationale Philatelique (FIP)* [www.f-i-p.ch](http://www.f-i-p.ch) and the *Federation of Inter-Asian Philately (FIAP)*.

- 1.2 Any exhibit, which has since 1 July 2022:
- Gained a Large Gold award at any South African National or Special National Exhibition, or a Gold or Large Gold award at any international exhibition, shall not be eligible for competitive entry for this exhibition except in Group B Class 01 (Championship Class), if offered.
  - Gained a Gold award at any Southern African National or Special National Exhibition shall only be eligible for competitive entry at this exhibition subject to the provisions of Clause 8.4.
- 1.3 Entries (other than literature) from outside of the RSA shall only be accepted provided the exhibitor or a duly delegated person, shall personally bring the exhibit into and out of the RSA.
- 1.4 The Organising Committee will not provide clearing or forwarding services.

### 2. SCOPE OF EXHIBITION

**Class 03:** Postal History, Historical and Historical/Social Studies

- South Africa, all periods (includes pre-Union areas)
- Great Britain and Commonwealth
- Rest of the World
- Historical, Social and Special Studies, all World

**Class 04:** Postal Stationery

**Class 05:** Aerophilately, Maritime and Disaster Mails

**Class 06:** Thematic

**Class 07:** Maximaphily

**Class 08:** Philatelic Literature, including Electronic Media (Entries are required by **1 June 2025**)

**Class 09:** Astrophilately

**Class 10:** Open Philately

**Class 11:** Picture Postcards

**Class 12:** Revenues

**Class 13:** Marcophily

**Class 14:** One Frame

Exhibits in this Class should not be One Frame extracted from a multiple frame exhibit and should be based on a narrow subject that is best treated as One Frame exhibits.

Awards are represented by points only (50 points to 100 points).

- Exhibits will be classified under the same classes as above.

**Class 14a:** Narrow Theme Experimental Class

Narrow theme exhibits (2 frames) are classified in their respective philatelic classes as above and are judge according to one frame guidelines.

Exhibits in this Class should not be extracted from a multiple frame exhibit and should be based on a subject that is best treated as a two-frame narrow theme exhibits.

- Awards are represented by point (50 points to 100 points).

### **3. ENTRIES AND EXHIBITS**

- 3.1 An [Entry Form](#) for each Exhibit should be completed and sent online.
- 3.2 There are no preliminary or final entry forms.
- 3.3 The fee per frame is **R250.00** (Foreign entries 25 USD) and payable on submission of the entry form.
- 3.3.1 One Frame, Narrow theme and literature: **R250.00** (Foreign entries 25 USD) per frame entered. (Banking details appear on the entry form).
- 3.4 There is no maximum number of entries for each exhibitor, however, if more than one entry is submitted, the exhibitor must signify his/her preference in case not all can be accepted.
  - No exhibit may be entered in more than one class.
  - For exhibits that previously gained up to a Large Silver award or have not been shown competitively at a National Exhibition, up to 5 frames may be applied for.
  - Where an exhibit has been awarded a Vermeil or higher at a National Exhibition, up to 8 frames may be applied for.
  - Notwithstanding the above, the committee reserves the right to allocate frames at its sole discretion.
- 3.5 The entry form of an exhibitor competing for the first time should be indicated on the entry form by also completing the last two blocks. The Society Chairman or Secretary of his/her home society should send such confirmation and consent that the exhibit is of national standard to the Organizing Committee via email.
  - This declaration will automatically enter the exhibit for the ERPS Floating Trophy which is awarded to a first-time philatelic exhibitor at National level.
- 3.6 Potential exhibitors should be a member in good standing of a Philatelic Society affiliated with the PFSA or a member of a society affiliated to member federations of FIP and FIAP.
- 3.7 Entries must be the *bona fide* property of the exhibitor for at least two years and the completion of an entry form is deemed an implied declaration to this effect.
- 3.8 All awards gained by an exhibit in the previous 3 years must be listed on the entry form.
- 3.9 The Organising Committee reserves the right to reject any entry or exhibit, in whole or in part, without having to provide any reason for such rejection.
- 3.10 When applying to enter the exhibitor is

invited to nominate the most appropriate class for the exhibit. However, the Organising Committee and the Jury reserve the right to transfer any exhibit from one class to another, always to the benefit of the exhibitor.

- 3.11 For each entry the Organising Committee must receive it before **15 July 2025**:
    - a) Completed entry form.
    - b) The prescribed frame fees (Clause 3.2).
    - c) PFSA Indemnity form.
    - d) A description of the exhibit in English or Afrikaans not exceeding 100 words (in MS Word) for inclusion in the exhibition catalogue.
    - e) Photocopy or scan of the exhibit's introductory page outlining the concept of the exhibit, which may subsequently be amended. **Please note** that the fundamental concept of the exhibit must remain unchanged.
      - A synopsis of not more than two A4 pages is optional.
  - 3.12 Exhibitors need to provide their own envelopes for submission of exhibits; one envelope per frame.
  - 3.13 Labels for each envelope, Exhibit Inventory list as well as method of submission, delivery and collecting instructions will be provided electronically after **15 July 2025**.
  - 3.14 Exhibits must be delivered to the Organising Committee not later than 10:00 on **2 September 2025**.
  - 3.15 **Philatelic Literature class (Class 08)** entries (see clause 3.1 and 3.2) are required by **1 June 2025** for judging purposes.
    - Apart from the entrant be a member in good standing of a Philatelic Society affiliated to the PFSA, two hard copies of the book are needed for adjudication.
    - After the exhibition, one copy is donated to PFSA library in Sandton and the other to the Organising Committee.
    - Periodical entries - same as above and a run of two years are required.
    - For entries of digital media, the above time limits do not apply but websites must be active, and software should run on current operating systems.
  - 3.16 Should any doubt or dispute arise as to the eligibility of any entry, the ruling of the Organising Committee shall be final.
- ### **4. EXHIBITION FRAMES**
- 4.1 Exhibition frames accommodate 16 sheets, each with a maximum height of 305mm. The daylight width of the frame is 900mm. Sheets will be mounted in a sequence of 4 horizontal rows of 4 sheets each. The minimum stiffness of the sheets must be 120 g/m<sup>2</sup> as

thin sheets are difficult to mount.

4.2 All exhibitors must provide their sheets with acetate or plastic exhibition covers to ensure the safety of their material – entries will not be accepted without exhibition covers.

- Sheet numbers must be shown at the front, bottom right corner of the page.
- Numbering is to be sequential within each exhibit, e.g., for a 5-frame exhibit. The sheets shall be numbered from 1 to 80.

4.3 Exhibits must be mounted on white or light-coloured pages and each sheet must be placed in a transparent protective cover. No exhibit mounted on black or dark coloured pages will be accepted.

## 5. LIABILITY AND INSURANCE

5.1 Although every possible care will be taken of exhibits while in the custody of a Commissioner/Organising Committee, such exhibits shall always be at the owner's risk.

5.2 Neither the PFSA, its officers, employees, members, Organising Committee and employees of a sponsoring society arranging this National Exhibition, nor any voluntary helpers, shall incur any liability for any loss or damage sustained by an exhibit from any cause or for any reason whatsoever.

5.3 The PFSA shall not be liable whether in contract, in tort, under any statute or otherwise for damage to or loss of my exhibit and for any loss consequential thereto including but not limited to loss of profit and loss of opportunity.

5.4 There will be no insurance cover – the onus rests with the exhibitors to arrange their own.

5.5 It is a condition of acceptance of each exhibit that the exhibitor's insurer waives all rights of subrogation against the PFSA.

5.6 Nothing in the rules in this Prospectus shall exclude or limit liability in respect of fraud or any statements made fraudulently.

## 6. JURY AND JUDGING FOR AWARDS

6.1 The Organising Committee has invited a qualified philatelist to chair and appoint the jury, which will comprise currently accredited judges of the PFSA or other suitably qualified judges. Other persons may also be nominated to act as apprentice jurors.

6.2 The jury chairman shall have full control over the activities of the jury, which shall be subject to the rules and by-laws of the PFSA. While the jury may call in any person/s as a consultant, neither consultant/s nor apprentice jurors shall have any vote in the jury's deliberations. The chairman shall have the casting vote.

6.3 The deliberations of the jury are confidential and its decisions, once announced, shall be

final and irrevocable.

6.4 Judging for awards will be solely based on the material submitted and exhibited in the frames. No further supporting matter will be required or permitted.

6.5 Limited copied material (photocopies or scans) used in exhibits must be clearly labeled and at least 25% linearly larger or smaller than the actual size of the item depicted.

- Original photographs in Class 03 (Postal History) are permitted in full size if they are part of the development of the exhibit.

6.6 Competitive exhibits will be judged on their individual merits and not against other collections, except in the case of the Grand Prix and other Special Awards.

6.7 No exhibition page may bear any indication of price or value, nor shall any exhibit in any way be advertised for sale.

6.8 Related exhibits of an exhibitor may be grouped together with a view of making an award for the whole greater than that which such exhibits might have obtained individually. Such combinations shall not receive a gold or large gold award.

6.9 An exhibit entered in a particular class may be transferred to another class with a view of making an award greater than it might otherwise have obtained, except for exhibits entered in class 15 (Modern Experimental).

6.10 An exhibitor providing fewer frames than requested and allocated shall not have that exhibit judged unless ordered by the Organising Committee prior to judging.

- A frame must be filled with relevant material.

6.11 Judging shall be based on current FIP rules for each class, where they exist and can be found on the FIP website [www.f-i-p.ch](http://www.f-i-p.ch)

6.12 Where exhibitors are not clear about FIP rules or PFSA interpretation thereof, please contact the Organising Committee stating the class of interest.

6.13 To determine the winner of Group B, Class 01 (Championship Class) will be by jury majority vote.

## 7. AWARDS (except for Class 01 and 14)

7.1 Exhibition Awards and points will be:

- 7.2 No exhibit may receive more than one exhibition award.
- 7.3 Each entry that is not given an exhibition award will receive a certificate of Participation.
- 7.4 Exhibition Awards and Certificates will clearly state for which class they were awarded.
- 7.5 In the Championship Class, only the winner of the class will be announced, and all entrants will receive a Large Gold award.

## 8. SPECIAL AWARDS

- 8.1 In addition to the exhibition awards, various special awards may be made available to the jury to be awarded within each exhibition group.
- 8.2 Class 15 exhibits are not eligible for special awards except for awards specifically for this class.
- 8.3 Within the Competitive Philately Group, the **Grand Prix** shall be awarded to the best competitive exhibit of not lower than gold award standard and shall take precedence over all other awards. The **Post Office Trophy** shall be awarded to the best exhibit of South African philately of not lower than gold award standard.
  - These two exhibits will not be eligible for any other special award.
- 8.4 An exhibit, which since 1 July 2022 has gained a gold award at any Southern African National or Special National Exhibition, will not be eligible for any special award unless at this exhibition it is awarded a Large Gold award.
- 8.5 No exhibit will be eligible for more than two special awards.

## 9. BLACKLISTED PHILATELIC MATERIAL

- 9.1 The PFSA has created a Blacklist, which details philatelic material reported by the South African Post Office to have been stolen from their Museum and Archive. This list was published in the February 2009 edition of *The SA Philatelist* on page 629 (read the article [here](#))
- 9.2 The PFSA have resolved that no exhibit containing blacklisted material shall be accepted for exhibition. If that is detected only after the exhibit has been mounted, the exhibit is to be disqualified and taken down forthwith.
- 9.3 The chairman of the PFSA Judging and Ethics Committee to be notified accordingly, for him

to notify the relevant Authorities.

- The Blacklist is maintained by the PFSA Judging & Ethics Committee.
- It is the responsibility of exhibitors to ensure they do not exhibit blacklisted material.

## 10. EXHIBITION MEDAL, CERTIFICATE AND CATALOGUE

- 10.1 Each accepted exhibit will receive a participation medal, a certificate and will be allocated one copy of the exhibition catalogue, which the exhibitor may collect at the exhibition, or which otherwise will be included with the exhibit upon its return, together with a copy of the awards listing.

- 12.2 Data provided will be used by the 2025 Stampshow for the purpose of organising the exhibition and will be stored and transmitted electronically, as well as in paper form. Submitting an application signifies the exhibitor's agreement to this. No data will be passed to third parties for any purpose other than retention for exhibition records by the FIP and may be used to provide the exhibitor with information about future exhibitions.
